(3) Both you and Radmetron agree that this dispute resolution procedure is a condition precedent which must be satisfied prior to initiating any arbitration or filing any claim against the other party.

(4) To the extent we cannot resolve any Dispute through the informal dispute resolution procedure a Dispute shall be determined and settled by arbitration.

(5) All dispute shall be sent for a consideration to the International Arbitration Court at National Chamber of Commerce of Republic of Belarus. The applicable governing law shall be the substantive law of the Republic of Belarus.

(6) The prevailing party in any legal action brought by one party against the other and arising out of this Terms of Use shall be entitled, along with any other rights and remedies it may have, to reimbursement for its expenses, including court costs and reasonable attorney's fees.

Termination

With the exception of the DISPUTE RESOLUTION, which shall survive the termination of these Terms of Use, these terms are effective unless and until terminated by either you or Radmetron. You may terminate this *Terms of Use* at any time. Radmetron also may terminate this *Terms of Use* at any time without notice, and accordingly may deny you access to the Website, if in our sole judgment you fail to comply with any term or provision of the Terms of Use.
